RECOMMENDING THE APPROVAL OF THE CONSOLIDATED UPDATES IN THE 2018 ANNUAL PROCUREMENT PLAN OF THE PAMANTASAN NG LUNGSOD NG MAYNILA FOR THE FIRST SEMESTER OF CY 2018

WHEREAS, under Section 7.2 of the Revised Implementing Rules and Regulations (RIRR) of the Republic Act (RA) No. 9184, no procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP) of the procuring entity;

WHEREAS, Section 7.4 of the RIRR of the RA No. 9184 further provides that the updating of Project Procurement Management Plans (PPMPs) and its consolidation into APP may be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity (HOPE);

WHEREAS, the various End-user units of the University proposed changes in their PPMPs for the 1st Semester of the year 2018, which were recommended by the BAC and approved by the HOPE.

WHEREAS, pursuant to Section 7.4 of the RIRR of the RA No. 9184, and in order to continuously have an efficient and judicious procurement planning, the Bids and Awards Committee (BAC) through its Secretariat has consolidated all the approved updates in procurement activities into an APP.

WHEREAS, all changes in the APP shall be submitted to the Government Procurement Policy Board in July of the current budget year as provided under Section 7.4 of the RIRR of RA No. 9184.

WHEREAS, the said Consolidated Updates in the 2018 APP shall be posted in the official website of the University, pursuant to Section 1.2 of the Implementing Guidelines of Executive Order No. 662, series of 2007, otherwise known as the Enhancing Transparency Measures Under Republic Act No. 9184 and Creating the Procurement Transparency Board.
