In view of the two (2) failed public bidding, the Pamantasan ng Lungsod ng Maynila (PLM) through its Bids and Awards Committee (BAC) invites interested bidders to participate in the Negotiated Procurement for the **Various IT Equipment and Software (CY 2016)** with an Approved Budget for the Contract (ABC) of **One Million Seven Hundred Sixty-One Pesos (PhP1,761,000.00)** in accordance with Section 53.1 of the Implementing Rules and Regulations of Republic Act No.9184, otherwise known as the "Government Procurement Act."

The following eligibility and technical documents as well as the Financial Proposal Form shall be submitted *on or before* **07 September 2018, 10:00 a.m.** at the Procurement Office, Pamantasan ng Lungsod ng Maynila Gen. Luna corner Muralla Streets. Intramuros, Manila:

#### Eligibility and Technical Documents:

- a) PhilGEPS Certificate of Registration Platinum Membership
- b) Statement of all ongoing government and private contracts, including awarded but not yet started whether similar or not similar in nature and complexity to the contract to be bid.
- c) Statement of Bidders Single Largest Completed Contract similar to the contract to be bid
- d) Bid Security issued in favor of PLM shall be either in the following forms and amount:
  - i. 2% of the ABC, if cash or cashier's/manager's check;
  - ii. 5% of the ABC if surety bond with certification from Insurance Commission that such insurance company is authorized to issue such security;
  - iii. Bid Securing Declaration.
- e) Audited Financial Statement stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar vear
- f) Net Financial Contracting Capacity (NFCC) Computation.
- g) Authority of Signatory/ Secretary Certificate
- h) Conformity with the Schedule of Requirements and Technical Specifications as specified in Sections VI and VII of the Bidding Documents (duly signed by company representative) and
- i) Omnibus Sworn Statement in accordance with Section 25.3 of the IRR;

- a) Financial Bid Form
- b) Schedule of Prices

An initial meeting for the Negotiated Procurement with interested suppliers will be conducted on **24 August 2018**, **10:00 a.m.** The Opening of the eligibility and technical documents and financial proposal will be on **07 September 2018**, **10:00 a.m.**
