This project shall be procured through an Ordering Agreement arrangement for a period of one (1) year in accordance with the Revised Guidelines on the Use of Ordering Agreement under GPPB Resolution No. 01-2012 dated 27 January 2012.

The delivery of goods is within seven (7) calendar days upon receipt of Purchase Order (P.O.) unless otherwise stated in the Purchase Order.

Prospective bidders should have experience in undertaking a similar project within the last 5 years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR) and the Revised Guidelines on Ordering Agreement under GPPB Resolution No. 01-2012.
